OLVF provides a range of programs and opportunities for all ages, backgrounds and socio-economic levels. Volunteer programs implemented by OLVF range from opportunities in the urban trail and park context to more rural volunteer experiences. Education programs target low-income youth lacking access to outdoor experiences, as well as encompassing broader-based programs that educate volunteers, trail users, and recreationalists. Outreach and coordination efforts include large planning projects such as the Vegas Valley Rim Trail (a 100+ mile trail that will one day encircle the Las Vegas Valley) and the Regional Open Space and Trails Workgroup (a working group of the Southern Nevada Regional Planning Coalition including planners from all local jurisdictions and federal agencies). OLVF serves as a hub for regional trail and outdoor information and events.

In 2014, OLVF education and volunteer programs continued to grow. OLVF education programs reached 19,052 people through 252 separate programs. 27 OLVF-funded field trips assisted 1,278 young people in connecting to the outdoors. The OLVF City of Las Vegas Adopt-A-Trail program generated 2,800 volunteer hours in 2014 through the efforts of 1069 people. In addition, volunteers assisted with events such as Get Outdoors Nevada Day and MLK Day of service, thus bringing OLVF's total volunteer hours to 4,798.5 (generated by 1364 volunteers). The estimated value of a volunteer hour in the United States is \$22.55. Thus, the 4,798.5 hours generated by OLVF volunteer events resulted in a \$108,206 value to the community. In 2014, OLVF entered into new agreements with City of North Las Vegas and Clark County for Adopt-A-Trail programs.
